- \$1,600 is applicable in branch if the customer is below the online transfer limit; and
- \$250.00 is applicable in branch if the customer exceeds the online transfer limit

<sup>6</sup> Companies are charged a fee of \$300 (for each credit) for incoming RTGS transfers with instructions to credit multiple accounts, e.g. payroll services.

<sup>7</sup> Customers are charged a fee of \$400.00 for the return of incoming transfers

<sup>8</sup> SNO means Service Not Offered.

<sup>9</sup> Customers are charged a fee for being above or below the allowable on-line transfer limit (Daily: \$500,000.00) as follows:

- \$895.00 is applicable in branch if customer is below the online transfer limit; and
- \$550.00 is applicable in branch if customer exceeds the online transfer limit.
